- Be named on the certificate of title as the person who owns property within the Summer Village Birch Cove, **or**
  - Be the Spouse or adult interdependent partner of a person who is on the certificate of title as the person who owns property within the Summer Village of Birch Cove.

**PLEASE NOTE:** it is an offence under section 148 of the Local Authorities Election Act to vote in an election where you are not eligible. Any person who votes, knowing they are ineligible, could be fined up to \$10,000 or face imprisonment of not more than six (6) months.

**PLEASE NOTE:** Due to changes to the Local Authorities Election Act, **VOUCHING** will **NOT** be allowed in this year's Summer Village Election.

**VOTER IDENTIFICATION REQUIREMENTS:** Electors will be required to fill out Form 13 SV – Elector Register for Summer Villages and present one piece of identification authorized by the Chief Electoral Officer that establishes the person's name and current address.
